

Focused Riding Schooling Day

June 14, 2020



*Note: Due to Covid-19, the Fun Show is replaced with a Schooling Day offering "Ride a Test" and "School a jump course" run much like a show. To keep from spreading the virus to other communities, riders that can get to the show grounds and home on one tank of gas are allowed to enter. **No judge, no ribbons**, but you can bring a family member to video you and be your own judge. Coaching during show offered by Jane Braddock, or bring your own coach! Overnight stabling offered only to riders also participating in clinic prior to show. Pre-entries ONLY. Entries will be limited to avoid crowding. Entry not complete until payment received. Payment MUST be received prior to closing.*

Dressage Pre Entry Closing Date: **Received** by NOON Sunday, one week prior to show

Dressage Tests: \$15 per class, no post entry.

Classes 3-15: Fees: \$15.00 per class, no post entry,

Classes 3-15: Closing Date: Received by 8am Wed, prior to show, including payment.

Refunds: No refunds after closing date | Class Add / Drops allowed for Classes 3 and up

Attire: ASTM approved helmets and boots with heels must be worn whenever mounted. Protective vests and medical armbands required for derby. FACE MASKS RECOMMENDED when unmounted, REQUIRED when you are within 10 feet of others.

Open Schooling: 8:00-9:00; Dressage Classes: 9-11:30am (approx); Additional Open Schooling Times in Dressage Ring will be published with Schedule

Class# Description - Large / Standard Ring for all tests

1. Dressage Test of Choice - First Ride: Indicate test on Entry Form
2. Dressage Test of Choice - 2nd Ride: Indicate test on Entry Form

BREAK - remaining morning classes to start no earlier than 11am

3. Ground Poles Course - Walk, Trot OR Canter
4. Cross Rails Course 1 - Walk, Trot OR Canter
5. Cross Rails Course 2 - Walk, Trot OR Canter,

BREAK reset jump courses, LUNCH - no food available for purchase on grounds, riders are encouraged to bring a bag lunch, Remaining Classes - to start 12:00pm or later

6. Pre-Starter Jumper over fences 12"-18"
7. Pre-Starter Derby (combination stadium and xc jumps outside the arena, not to exceed 18")
8. Starter Jumper over fences 2'-2'3"
9. Starter Derby (combination stadium and xc solid jumps outside the arena, not to exceed 2'3")
10. Beginner Jumper over Fences 2'6"-2'8"
11. Beginner Novice Derby (combination stadium and xc solid jumps, not to exceed 2'7")
12. Novice Jumper over Fences (max 2'11")
13. Novice Derby (combination stadium and xc solid jumps, not to exceed 2'11")
14. Training Jumper over Fences (max 3'3")
15. Training Derby (combination stadium and xc solid jumps, not to exceed 3'3")

I have read and understand the warnings listed above regarding horses and their environment. I understand that I am responsible for maintaining control of my person and the equipment, devices, or animals I may be using while participating in activities on the above-stated premises. I further understand that it is my responsibility to refrain from acting in any manner that may cause or contribute to injury to myself or to others while participating in activities on the above-stated premises.

I hereby represent that I am capable of using and being in close proximity to horses and their environment. I further represent that I am competent and capable to participate in the activities I will be participating in and agree to act within the limits of my abilities.

I hereby release, waive, and forever discharge Jane Braddock, her employees and/or volunteers and agents, Focused Riding, and their employees and/or volunteers, agents, owners, shareholders, officers, and directors from any and every claim, demand, action, or right of action, of whatever kind or nature, either in law or in equity, arising from or by reason of any bodily injury or personal injuries known or unknown, death or property damage resulting during my presence or the presence of my family or spectators at Focused Riding or at alternate locations, whether or not such injury, property damage, or death is caused by negligence. I assume full responsibility for the risk of bodily injury, death, or property damage during my presence or the presence of my family or spectators at Focused Riding, or at alternate locations, and hold Jane Braddock, her employees and/or volunteers and agents, Focused Riding, and their employees and/or volunteers, agents, owners, shareholders, officers, and directors harmless from any liability therefrom.
